The plaintiffs in each case are Washington residents. The defendant is the same as in this case, Washington Governor Jay Inslee, except that Chris Liu, Director of the Washington Department of Enterprise Services, is an additional defendant in *Faust v. Inslee*. Because all lawsuits challenge Governor’s Proclamation 20-25 (the “Stay Home – Stay Healthy” Order) under

1 varying legal theories, they “concern[s] substantially the same event,” and “it appears likely there
2 will be . . . the potential for conflicting results if the cases are conducted before different judges.”
