
1. My name is Clint Didier, and I am the chairman of the Franklin County Republican Party.

2. As the chairman, I have been deprived the right to assemble to amass a challenge to Democratic Govenor Jay Inslee. Inslee, in his Proclamations, has seen fit to terminate all political gatherings which might rise to challenge his authoritarian control of this state.

3. Inslee's order have prevented us from having two executive meeting and two regularly scheduled meeting of the PCO here in Franklin County.

This is my declaration signed in Pasco Washington, this 14 day of May 2020.

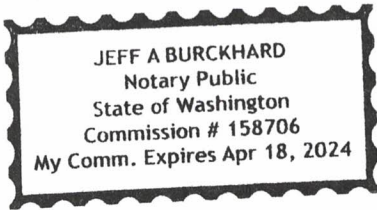
