### **Documents Instructions:**

- Candidates must have the required experience/qualifications to be processed
- All documents should be reviewed by us before submission
- Document copies must be 100% legible
- Documents must be saved separately in .PDF or .jpg format
- Documents that require to be scanned from 2 sides should be combined into one file
- Documents should be named as follow: 1 EB-3 APPLICATION FORM SURNAME, Name; 2 PROFILE PICTURE SURNAME, Name, and so on...
- Documents that require translation should contain the original and English translation: 1 EB-3
   APPLICATION FORM SURNAME, Name, 2 PROFILE PICTURE SURNAME, Name, and so on...
- Documents should be made available via e-mail in pdf.

### **DOCUMENTS INSTRUCTIONS:**

### 1. PERMANENT RESIDENT APPLICATION FORM

Candidates must follow the instructions contained in the online EB-3 Worksheet in our Immigration portal.

## 2. PROFILE PICTURE

We require a full-face color photo of the candidate taken within the last 6 months, similar to a passport photo. Must be saved in .jpg

### 3. VIDEO INTERVIEW IN ENGLISH

Candidates must record a casual video of maximum 1 minute long answering the following questions:

- Complete name and background
- Previous experience
- Reason why the candidate wants to immigrate to the USA

We will not accept any videos recorded while driving.

### 4. COMMERCIAL DRIVER LICENSE AND CDL APPLICATION

It is essential to submit a copy (front and back) of the candidate's valid CDL and fill out CDL application. The copy must show the required driving category.

# 5. CRIMINAL RECORD VERIFICATION

Document needs to be submitted together with a translation if was not issued in English.

# 6. DRIVER ACCIDENT HISTORY VERIFICATION

Document needs to be submitted together with a translation if was not issued in English.

<sup>\*</sup>We require the candidate's data log to be updated once a week with the status of their documents.

#### 7. PASSPORT

Passport must be valid for a minimum of 18 months from date of submission.

# **8. PRE-MEDICAL CERTIFICATE** (Or proof of Payment)

9. U.S.A. VISAS (If ever had one)

### 10. EMPLOYMENT VERIFICATION FORMAT

Employment to be verified by an HR manager or agency/recruiter.

# 11. BIRTH CERTIFICATE

Birth Certificate cannot be laminated.

#### 12. MARRIAGE CERTIFICATE

Marriage Certificate cannot be laminated.

# 13. DIVORCE OR SPOUSE'S DEATH CERTIFICATE (if applicable)

Divorce or death certificate of a previous spouse.

# 14. EXPERIENCE VERIFICATION LETTER (EVL)

The standard form of documentation of work experience is a letter from a former employer, academic advisor, or professor, stating the job title, hours worked per week, dates of employment, and brief description of duties.

### 15. FAMILY

Each family member will need to fill out a separate worksheet for an immigrant visa application on our portal.

## 16. POLICE CLEARANCE CERTIFICATE

Candidates must obtain a Police Clearance from every country that they have previously lived for at least 6 months since the age of 16.

# 17. MILITARY RECORDS

If candidate has served in a military, a copy of military record/card/certificate is required.

# 18. DS-260 QUESTIONNAIRE

Candidates must follow the instructions and complete the online DS-260 Form maximum 30 days after DOL approval.
